WAWFE TROPHY

The Scientific Prize “**WAWFE Trophy**” is an international award given by WAWFE in order to promote scientific knowledge, meritocracy, professionalism, integrity and competence by rewarding young professional men and women worldwide.

The Contest will take place according to the rules described in the following articles:

Article 1 **PROMOTER**

The contest promoter is the World Association of Women Forensic Expert (WAWFE) with legal office in Italy. WAWFE organizes events, conferences, meetings, seminars, scientific meetings, projects, workshops and contests at national and international level in the field of forensic science.

Currently the Association has Area Coordinators in many Countries. (www.wawfe.org)

The contest notice is published only in English language.

Article 2 **OBJECT**

The Scientific Award “WAWFE Trophy” aim is to reward young professional men and women who have distinguished themselves in the field of forensic science in the world.

Article 3 **RECIPIENTS**

Men or Women experts from all over the world working as professional in the area of forensic science (i.e. forensic nursing, forensic psychiatry, forensic medicine , criminology, forensic anthropology, forensic archeology, forensic engineering, medical law and bioethics, forensic odontology, forensic, forensic zoology, forensic entomology, forensic botany, graphics and sound forensic ballistics, latent prints, DNA analysis, toxicology, BPA, security, intelligence, investigation) who satisfy the following requirements:

- Minimum education: BSC and Master Degree;
- Age not more than 35 years old by March,27, 2014;
- no prior criminal convictions or application of penalty, not subject to criminal proceedings or proceedings for the application of preventive safety measures, not under trial.

Article 4 **PARTICIPATION**

The competition is free but only WAWFE members, in compliance with the payment of the annual membership fee for 2014, can apply to participate in the contest .

Requests to participate in the contest should be sent to the email address events@wawfe.org no later than November 30, 2014 at 20:00 and they must include:

- application form
- passport or ID copy
- CV including references of scientific publications
- copy of certificates attesting qualifications and titles

Participants must declare personal data, telephone number and e-mail address, the possession of the requirements for the selection, filling in the enclosed form, under penalty of inadmissibility of application, duly signed and accompanied by the curriculum vitae.

WAWFE has the power to eliminate from the contest participants if it finds any violation of the rules by the participants without giving any alert.

Each participant is required to provide a valid e-mail address to receive communications from the organization. The Association is not responsible in any way for non-receipt of communications.

Article 5 **AWARDS**

The winner will be notified by e-mail and will receive from the Worldwide Association of Women Forensic Experts a certificate and Scientific Award "WAWFE Trophy" .

The winner name will be advertised by the Association in all the WAWFE communication channels (FB, Twitter, LinkedIn, etc)

Date time and place of the proclamation will be communicated to participants by January 2015.

Article 6 **SCIENTIFIC JURY**

All CV received will be evaluated by members of the WAWFE Board.

The Scientific Award WAWFE Trophy will be assigned at the discretion of the WAWFE Board to the most relevant professional profile between candidates.

Article. 7 **ADVERTISING**

The contest will be advertised in the terms and manner in accordance with this Regulation.

In the period of the validity of this Regulation, the Association, at its sole discretion, may make to additions and changes to organizational and functional needs.
